Bitches in season will be allowed to participate. Please keep bitches in season in your vehicle and notify the Test Secretary upon your arrival for instructions.

All American dogs and the Test Secretary are allowed to compete in the VST test. Workers Preference* See Section 17d of the Tracking Regulations which can be found on AKC web site.

Dogs who may not Compete:

No dog under the age of 6 months may compete in tracking events.

No dog belonging wholly or in part to a judge, test secretary, superintendent, official veterinarian, or any member of such a person's household may be entered in any Tracking Test at which such person officiates or is scheduled to officiate. Nor may they handle or act as agent for any dog entered at that test.

Errors on Entry:

Owners are responsible for errors on entry forms, whoever may make such errors. No entry fee will be refunded in event of errors. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries cannot be accepted, canceled, altered or substituted after the entries have closed. Mail both sides of the entry form and fees to: Alexandra Whitman, 6201 Glen Hill Road, Louisville, KY 40222. Make checks payable to Greater Louisville Training Club. Phone or fax entries will not be accepted. Express mail entries must include the signature waiver. Illegible or incomplete entries will not be processed and will be returned to the exhibitor. Receipt of entries will be acknowledged via email; please provide a valid email address with entry. 100 percent of entry fees will be refunded (check destroyed) for any reason if written or email withdrawal request is received by the Test Secretary on or before the closing day and time.

Event Cancellation:

The well-being of the dogs, exhibitors and spectators is of paramount importance, and in the event it is necessary to cancel or stop the event before completion, refund of entry will be made.

Draw:

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached. Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the Test will be held at the residence of the Test Secretary, on Sunday, March 31, 2024, at 6:30 p.m. EST. The drawing is open to the public. This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a VST title. When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above. The test secretary will notify all entries of the result of the drawing within 48 hours by telephone or email. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees shredded.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
