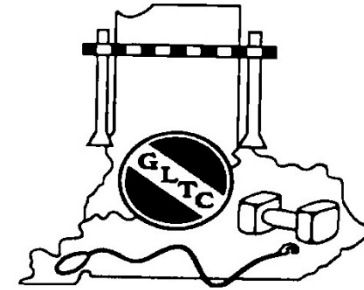
In accordance with the AKC Obedience Regulations, entries in this Tracking Test shall be accepted up until the official closing date even though the advertised limit has been reached. The drawing for this test shall take place on Friday, October 23, 2015 at the home of the Test Secretary, Myrna Keenan, 101 Blue Grass Road, Elizabethtown, KY 42701 at 6:00 PM and the public is invited. At that time it will be determined which of the entries will participate in the event. The drawing will be at random among all entries but preference will be given to dogs which have not earned a TD title and preference for two entries will be given to workers at a previous test. When the limit has been drawn, all remaining entries shall be drawn in the same manner and assigned a position on the alternate list.

**ALL ENTRIES WILL BE NOTIFIED BY PHONE OR EMAIL
ASAP**

Entry fees will not be refunded for any reason other than for bitches who come into season after the closing date, alternates who do not run, and entrants replaced by an alternate at the test. Bitches in season entries will be returned, less \$10.00, by turning in a statement from a veterinarian before the drawing of tracks on the test day. Entry fees will be refunded within seven (7) days following the test. In the event an accepted entry cancels prior to the test date, the test secretary shall contact alternates according to their placement on the alternate list and upon notification, said alternate shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the judges to assign dogs to the tracks by the drawing of lots.
